# Vendors:

**You must also fill out and return the ST-19 OR Vendor Without Tax ID form with your registration.**

1. To be pre-registered your money, registration form and the appropriate tax form must be received by May 15, 2025.
2. Vendors **must** be pre-registered, to hold the same spaces they had last year.
3. The spaces will be marked with your space number and may be in a slightly different location than the previous year.
4. **THERE WILL BE NO EARLY SET-UPS. TO AVOID CONGESTION \*DO NOT ARRIVE BEFORE THE DESIGNATED SET-UP TIME FOR YOUR LOCATION.**
5. Registration fees:  
**Outside vendors:** Registrations received by May 15th are \$60/space. Registrations received after May 15th is \$70/space. Spaces are **approximately** 10X30.  
**Inside vendors:** Registrations received by May 15th are \$70/space. Registrations received after May 15th is \$80/space. Spaces are **approximately** 10X12. All spaces are dependent upon availability.  
**Passes:** Vendors are allowed 1 pass/space (if needed). Additional passes are \$5 each. Passes must be hung on your inside rearview mirror to enter the Fairgrounds, which allows you to enter at no charge. Vendors MAY NOT park OR set up on vacant spaces.  
**Camping fee:** If you are camping on your space, there is a \$20 charge per vehicle that is camping on your spaces. This new charge is due to an increase in our insurance which is related to those camping on the property and not on the actual campground.
6. Vendors are responsible for all damages. Please carry your own liability insurance.
7. You will receive a confirmation notice by mail or email (if available) as we receive your payment and registration forms. Please contact the Grand Rapids Area Chamber at (218)326-6619 if you do not receive confirmation *within 20 days of registering*.
8. We **do not** collect camping fees for camping at the Itasca County Campground. Camping on your outdoor vendor space is allowed **after** set up for an **additional charge of \$20**. Make sure you have room to open doors etc.
9. We will hold pre-registered spaces until SATURDAY at noon unless we are notified ahead of time that you will be arriving in the afternoon on Saturday. *Refunds are available if cancellation is received by July 21, 2025.*
10. **FAIR BOARD POLICY:** *No dogs allowed except service animals. No golf carts, ATVs, or side by sides.*
11. **Vendor stock must consist of auto-related items, antiques and collectibles, personally handcrafted items, and art items ONLY. No used clothing or rummage sale items are allowed. NO SALE OF FOOD ITEMS ALLOWED. (Except for booths staffed by the Grand Rapids Area Chamber of Commerce or its authorized agents). Approved item questions/concerns can be directed to Stacia Rom at (218)326-6619.**
12. Any ATVs, motorcycles, scooters, bikes, skateboards, or rollerblades that are for sale need to be kept in vendor spots and may not be ridden during the event.

If you are not pre-registered, you will need to fill out a Vendor Registration Form and the appropriate tax form. You will then be assigned a vendor spot after pre-registered vendors are set up.
